- Start recording a live interaction.
- Pause or resume a recording.
- Stop a recording.
- Cancel a recording.

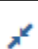

Chapter 4: Monitoring interactions in real time

Live Monitoring overview

With the Live Monitoring module, supervisors and managers can silently monitor real-time interactions of employees to assess and measure performance. Supervisors and managers can identify problem areas and take immediate steps to ensure customer satisfaction.

The Live Monitoring module provides the following benefits:

- Listen to agent and customer interactions in progress and view real-time agent information and interaction status.
- Respond to and mitigate caller objectives or complaints by providing instant feedback.
- Create different views that define individual search criteria to quickly access the required live interactions for listening.
- Customize various columns to quickly identify important interaction details, such as extension, queue, tenure, call duration, current state, current state duration, and ANI number.
- Allow supervisors to perform QA while monitoring to measure agent performance on aspects like average handling time and adherence to scripts provided by management. Supervisors can also flag an interaction for further evaluation.
- Email an interaction as a link to anyone.
- Record live interactions
- Pause or resume a recording
- Cancel and stop a recording

Using the Live Monitoring module, authorized users can:

- Manage views
- Monitor live interactions

Monitor Live Interactions

Supervisors and authorized users can view and monitor the live interactions of team members and employees they have access to and provide timely feedback and coaching.

From the Monitor page, you can:

- Assist new agents by providing immediate feedback when required.
- Track employees whose average handle time, hold count, or hold duration is high.
- View color coded interactions that are defined based on the interaction duration.
- Configure to listen to interactions of specific agents at regular intervals. The interaction will automatically play in the order of selection.
- Customize the page to add columns that display interaction details such as extension, queue, tenure, and duration.
- Filter your search on specific columns by using conditions and operators.
- Use the pagination option to specify how many records you wish to view per page.


Play Live Interactions

While playing a live interaction, you can perform the following actions:

- Record an interaction using the recording controls.
- Add comments and tags to an interaction.
- Provide feedback to employees about an interaction.

Supervisors or managers can subscribe to get relevant alerts about an employee whose average handle time (AHT) or hold count is high. In such cases, the supervisor can listen to the live interactions of those employees to respond and mitigate caller objectives or complaints.

Note:

If a voice or a non voice interaction configured for screen capture recording is paused, then during live monitoring, Avaya Workforce Optimization Select displays the  image to indicate that no screens are captured during the paused state.

Manage views

Using views, you can filter data by specific criteria.

Depending on the business requirement, you can create different views with filters using logic conditions. For example, to search for live interactions that have been put on hold a number of times, you can define filters based on **Greater Than** or **Between**. The view displays the interactions that match the search criteria.

Note:

When you log in to the application the first time, the system displays the AWFOS view, which is the default view. You can create a new view to search and play the desired interactions.

After you create a view, you can use it anytime later.

You can do the following while creating views:

- Create multiple filters.
- Use the default view that comes with a preconfigured set of parameters.
- Define the search criteria with a comprehensive list of parameters.
- Use operators to add multiple filters to use multiple parameters for a view.
- Use the option to display additional columns in the live interactions list.
- Share Views that you create with other users.

Manage tags and reason codes

Tags overview

Use tags to classify interactions and enforce specific actions on interactions. You can associate a tag with a specific action. As a result, when you tag an interaction, Avaya Workforce Optimization Select executes the action associated with the tag. Naming a tag based on the action associated with it is a good practice for better identification.

If you do not want to associate any action to an interaction, associate the **No action required** tag to the interaction. You can use such tags to filter interactions with specific business needs. You can also associate such tags with business criteria. When Avaya Workforce Optimization Select fetches the interactions that meet the business criteria, these tags automatically get associated with the interactions.

Benefits:

- Supervisors can take advantage of tagging a live or a recorded interaction to execute certain actions or to filter interactions.
- Supervisors or managers can create multiple tags for the same action.

Avaya Workforce Optimization Select contains a default tag, which is Flag for QA. In a Data Partition (DP) environment, the following default tags get automatically created for each DP OU:

- Flag for QA
- Do not allow download
- Do not allow download and email
- Do not allow email

Apart from these, you can also create and manage additional tags based on your requirement.

Note:

You must have the appropriate permissions to manage tags in Avaya Workforce Optimization Select.

Reason codes overview

Reason codes in Avaya Workforce Optimization Select is a feature that forces you to provide a reason when you use a recording control. Whenever you start, stop, pause, resume, or cancel the recording of an interaction, you are forced to provide a reason. Depending on the privileges assigned to you by your administrator, you can create additional reason codes apart from the default ones and associate them to the interaction.

Benefits:

- An auto-resume feature is available when you pause a recording to automatically resume recording after a predefined time interval. You can select a specific time interval in seconds to automatically resume a call.
- The reason codes that are specified as default get automatically tagged to the interaction on clicking the recording control.
- At a DP OU level, you can associate a reason code to a single client or to multiple clients.

While monitoring an interaction in real time, supervisors and managers can add comments to provide specific information about the interaction.

Procedure

1. Click **Live Monitoring > Monitor**.
2. On the Monitor page, click the  icon next to the live interaction that you want to comment on.
3. On the Interaction Details, click **Comments/Tags**.
4. In **comments**, enter a comment.

You can only update or delete the comments that you add. However, if you have access to the interaction, then you can view all the comments made by others.

5. Click **Submit**.

Chapter 5: Managing recorded interactions

Interactions overview

Using the Interactions module, authorized users can view and manage interactions of the employees that they have access to. During interaction playback, the supervisor can view details of each segment of an interaction to determine if the call was transferred or put on hold.

 **Note:**

With appropriate permissions, employees can also view their own interactions.

The Interactions module provides the following benefits:

- Playback recorded interactions including recordings done by an external party, or in a legacy system in the wav-G.711aLaw-mono, wav-G.711aLaw-stereo, wav-G.711uLaw-stereo, wav-G.711uLaw-mono, wav-PCM-stereo, wav-PCM-mono, wav-G.711-uLaw-stereo, wav-G.726-stereo, wav-G.726-mono, wav G.729-mono, mp4-H.264-stereo, mp4-H.264-mono, m4a-AAC-stereo, and m4a-AAC-mono audio formats.
- Create different views to define search criteria and quickly access the interactions that you want to frequently view and listen.
- Create adhoc interactions to listen to an interaction series, voice or non-voice, between a customer and the employees of an organization. You can either create interactions by importing from an external source or group a series of interactions to form composite interactions. Composite interactions can be a combination of system interactions, imported interactions or both. The supported formats for uploading adhoc interactions are: .wav, .m4a, .mpeg-4, and .mp3.
- Add comments to a recorded interaction especially when the supervisor wants to provide important information to the evaluator or reviewer.
- Download a recorded interaction in .wav, .mp4 for audio and screens, and m4a for mp4 audio formats.
- Use existing tags or create one to apply to an interaction. Using tags, supervisors or managers can restrict specific actions on interactions such as downloading or deleting of interactions.
- Customize the Interactions page with columns to quickly identify important interaction details. For example: The columns could be interaction start time, interaction end time, duration, who ended the interaction whether the customer or the agent, number of holds, number of transfers, and hold duration.

- Get a visual depiction of the conversation graphs that provide quick identification of problem areas such as crosstalk or elevated voices.
- View all interaction segments such as conference, transfers, and caller experience details.

Using the Interactions module, authorized users can:

- Manage views
- View recorded interactions
- Play recorded interactions

View recorded interactions

Supervisors can view and monitor recorded interactions and get a quick snapshot of how the team members are performing.

You can view and track recorded interactions to:

- Listen and assess recorded interactions of new employees.
- Identify employees whose average handle time and hold count is high.
- View the number of interactions handled by each employee, comments added to interactions, and interactions that are already played.
- Customize the page to add columns that display interaction details such as extension, queue, tenure, and duration.
- Filter your search on specific columns by using conditions and operators.
- Use the pagination option to specify how many records you want to view per page.



Play recorded interactions

The Avaya Workforce Optimization Select application automatically records interactions and captures screen shots of agent's desktop which appear when playing back an interaction.

While listening to a recorded interaction, you can:

- Add comments to provide information to the evaluator or reviewer.
- Download a recorded interaction in WAV, MP4 (Audio only), and MP4 formats.
- Tag the interaction to enforce an action or filter interactions based on custom business needs.
- View the conversation graph that provides quick identification of problem areas such as cross talk or elevated voices.

Note:

- If a voice or a non voice interaction configured for screen capture recording is paused, then during playback, Avaya Workforce Optimization Select displays the  image to indicate that no screens are captured during the paused state.
- If a voice or non voice interaction configured for screen capture recording is terminated when the recording is paused, then during playback, Avaya Workforce Optimization Select displays the  image during the paused state and at the end of the screen cast.

Manage views

Using views, you can filter data by specific criteria.

Depending on the business requirement, you can create different views with filters using logic conditions. For example, to search for live interactions that have been put on hold a number of times, you can define filters based on **Greater Than** or **Between**. The view displays the interactions that match the search criteria.

Note:

When you log in to the application the first time, the system displays the AWFOS view, which is the default view. You can create a new view to search and play the desired interactions.

After you create a view, you can use it anytime later.

You can do the following while creating views:

- Create multiple filters.
- Use the default view that comes with a preconfigured set of parameters.
- Define the search criteria with a comprehensive list of parameters.
- Use operators to add multiple filters to use multiple parameters for a view.
- Use the option to display additional columns in the live interactions list.
- Share Views that you create with other users.

Adding a view

Use the view option to search for interactions based on the filters you specify.

By default, the AWFOS Default view comes with a set of pre defined filters configured by the system administrator. You cannot modify the filters on the AWFOS Default view. You can also save a view as an adhoc report.

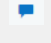

Manage tags and reason codes

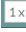

Response Sets overview

Response Sets are scoring variables that you can use to measure agent performance against a criteria. Response sets can range from being a Yes/No/NA or Comply/Does not comply to a grading scale of 1 to 5. You can choose a response set while building an evaluation form to define a scoring variable for a criteria.

For example, assume that you have a criteria to measure whether or not an agent greets the customer. The response set for the criteria can be Yes or No. Hence, depending on the questions you create for every criteria, you can determine the different response sets you want to add.

When you modify a response set, the changes are reflected in the evaluation form only when you again pick the response set against a criterion. Else, the previous response set is considered. You cannot delete a response set if there are evaluations associated to the response set.

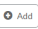

Evaluation Forms overview

Evaluation Forms are instruments that you can use to track the quality of an interaction.

Building an evaluation form involves the following tasks:

- Configure the re-evaluation lock-out time to specify the number of days after which the evaluation cannot be edited. Configure the appeals lock-out time to specify the number of days, post evaluation, after which the employee cannot raise an appeal.
- Configure options that enable the evaluator to enter additional information about the interaction being evaluated.
- Enforce the evaluator to feed comments while evaluating an interaction.
- Associate departments, queues, and organization units to an evaluation form. Interactions of agents belonging to only these associations can be evaluated using the evaluation form.
- Add parent and child criteria to determine the measures on which the interaction must be evaluated. You can associate a response set (scoring variable) to a criterion. You can set a response for conditional branching to define if a particular response must trigger additional questions. You cannot associate scores to the additional questions. However, the responses to the additional questions facilitate the evaluator in deciding whether to award a bonus or penalty.
- Define scoring conditions like bonus, penalty, exclude from scores, and not applicable. You can add a bonus or penalty at the parent criteria level, child criteria level, or at the overall

evaluation form level. The bonus or penalty will be a part of the overall score that is calculated for an evaluated interaction. Use the exclude from score option if you do not want to tie any score to a response. Use the not applicable option to restrict the user from adding a bonus or penalty to a response.

- Assign courses or quiz to agents based on the response of the evaluator.
- Define the evaluating mechanism as weighted or nonweighted. If you select nonweighted, the scores achieved at the child criteria level rolls up to the parent criteria. The overall score is a sum of all scores achieved against the criteria. If you select the weighted option, you must define weights for every criteria. Weights defined at every criteria node (parent or child) must sum up to 100. The score achieved at the criteria will be a product of the raw score and the weight.

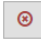

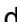

As a Supervisor, Reviewer, or a QA specialist, before performing evaluations on interactions, you might want to perform a test or a mock evaluation. Avaya Workforce Optimization Select gives you the flexibility to create Evaluation Types to meet such specific requirements. You can create an Evaluation Type to perform evaluations for either testing or training purposes. You can use the Evaluation Type feature as a platform to train new hires within your organization.

Typically, interactions assigned through Evaluation Plan, Calibration, or Flagged interactions automatically default to the Normal evaluation type and cannot be edited. For such evaluations, the system calculates the agent's performance based on the ratings and scores given by the evaluator. However, for the evaluation types you create, you have the option to specify whether or not you wish to include scores in evaluations. For example, you might want to create a training, mock, or adhoc evaluation type to train Evaluators. In such cases, you need not include scores to be considered in reports and notifications.

Appeals Workflow overview

The appeals workflow is a mechanism that you can use to automate the appeals process. Using the appeals workflow, you can define who can appeal, who can review, who can approve, who can escalate, and who can finally approve.

Every appeal raised moves through specific workflow states before it is finally approved by the Final Approver who has the permissions to finally approve the appeal.

The permissions in the appeals workflow is defined at the role level. The Reviewer can be the supervisor who provides feedback on the appeal, while the Approver is the Manager who reviews and approves the appeal.

Evaluation Metric overview

You can create an evaluation metric from the Evaluation Forms definition screen by associating the metric to a particular criteria. The measures related to the metric get created as evaluations. You can create multiple metrics for a particular criteria. Whenever a evaluation is performed on this evaluation form, the score in the measure gets applied to that particular metric. For example, you might have a evaluation form with the criteria:

`Is welcome message prompted?`

and you want to find out how many agents are greeting the customers with an welcome message. You must tag this metric as a criteria and then create a performance scorecard. For those employees who did not greet the customers, the system displays the score as zero.

Deleting an evaluation metric from the metrics screen disassociates it from the evaluation form. However, you can delete an evaluation metric only when it is not associated with any scorecard or metric views. To delete the metric, you must first disassociate it from any scorecard or metric views where it is used.

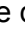

Adding evaluation comments


About this task

Evaluators, managers, and supervisors can add comments to an evaluation either while they are scoring it, or after complete scoring the form. Agents can add comments to an evaluation after the evaluation is scored.

There are two types of comments that you can add when evaluating an interaction.

- Form comments: General comments that apply to the entire evaluation form.
- Evaluation criteria comments: Comments that apply to a specific criteria that you are evaluating.
- Snippet comments: Comments that you can add to a particular segment of the interaction. You can specify the start time, end time, and severity for a snippet comment.

Procedure

1. Click the **Comments** () icon to the right of the evaluation criteria, and enter comments.
2. Enter your comments in the text area.
You can see the comments after you save the evaluation form.
3. In **General Comments** , enter overall comments for the evaluation.

Evaluation score calculation

The evaluator or reviewer scores the interaction by selecting appropriate responses against criteria. The evaluator scores the interaction by responding to the evaluation questions in the form and analyzing how the employees handle the interaction with customers.

The scoring mechanism can be weighted or nonweighted and the final score is awarded differently for each scoring mechanism.

The overall score is calculated accordingly:

- For nonweighted evaluations, the scores achieved at the child criteria level roll up to the parent criteria. The overall score is a sum of all scores achieved for the criteria.
- For weighted evaluations, weights are defined for every parent criteria, criteria and child criteria. The weights must sum up to 100.

The score achieved at the criteria is a product of the raw score and the weight.

- The bonus or penalty is calculated at the parent or child criteria level, or at the overall evaluation form level.

If the evaluation form has an associated bonus or penalty as a percentage of the criteria score, the overall score is calculated accordingly.

Example

Consider the following evaluation form with criteria and sub-criteria:

Section A: Greeting

- C1: Did the agent or employee greet the customer properly?
- C2: Did the agent or employee identify themselves with the customer?
- C3: Did the agent or employee mention that the interaction is being recorded?

Section B: Customer Service

- C1: Did the agent or employee verify the information provided by the customer?
- C2: Did the agent or employee rush or talk over the customer voice?
- C3: Did the agent or employee show empathy towards the customer?
- C7: How was the overall performance of the employee?

A bonus and penalty is given for evaluation responses 1, 2, and 3 at the parent criteria level. For response 1 and 3 from the evaluator, a bonus of 2% and 3 points is awarded. For response 2, a penalty of 1% is awarded.

The evaluation form is a weighted form, with the weightage given to criteria C4 to C7 towards the overall scores given as 20, 10, 10, and 50.

The employee receives scores 3, 5, 2, 8, 5, 5, 10 for the evaluation criteria C1 to C7 based on the evaluator scoring the interaction.

The total score is displayed after the evaluator scores each question in the form.

The overall scores are calculated as follows:

Criteria score with bonus and penalty

For bonus and penalty given as percentage, the score is calculated as:

Criteria score = Bonus or penalty percentage/100 added to or subtracted from the actual score that is awarded..

For bonus and penalty given as raw score, the score is calculated as:

Criteria score = Bonus or penalty raw score plus or minus the actual score that is awarded.

- Bonus score for criteria C1 = 2 percent of 3 = 0.06.

Criteria C1 score = 3 + 0.06 = 3.06

- Penalty score for criteria C2 = 1 percent of 5 = 0.05

Criteria C2 score = 5 - 0.05 = 4.95

- Bonus score for criteria C3 = 1 points.

Criteria C3 score = 2 + 1 = 3

Criteria score based on weightage

For criteria C4 to C7, the score is calculated as score weight x the actual score that is awarded.

Score weight = weightage percentage/100

Criteria score = weighted percentage/100 x actual score that is awarded.

The scores for criteria are:

- Criteria C4 score = $8 \times 0.2 = 1.6$
- Criteria C5 score = $5 \times 0.1 = 0.5$
- Criteria C6 score = $5 \times 0.1 = 0.5$
- Criteria C7 score = $10 \times 0.5 = 5$

The overall form score is the total of all criteria (parent) and sub-criteria (child criteria) scores in each section of the form. $3.06 + 4.95 + 3 + 1.6 + 0.5 + 0.5 + 5 = 18.61$ points.

The overall score is rounded off to 19 points.

Acknowledging an evaluation

About this task

After an evaluation is complete, the concerned employee receives a notification about the evaluation score achieved with comments, if any. It is at the discretion of the employee to accept, appeal, or take no action for an evaluation.

- Accept the evaluation.
- Appeal for another round of evaluation.

You can raise multiple appeals for the same evaluation. However, if an appeal is in progress, you cannot simultaneously raise another appeal for the same evaluation.


You can also just view the interaction and take no action. In this scenario, the acceptance status displays **No Action** when you view the evaluation.

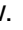

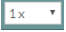

Avaya Workforce Optimization Select provides the user with the flexibility to perform calibrations for non voice interactions such as email and chat transactions

Appeals overview

Appeal summary

The **Appeals** feature in Avaya Workforce Optimization Select allows an employee with appropriate permissions to appeal against an evaluation. An employee can raise an appeal from the View Evaluations screen against each criterion.

The appeals process can be summarized as follows:

- An employee who belongs to the creator role defined in the appeals workflow, can raise an appeal against an evaluation. It is not necessary that only agent can raise an appeal. Any user who has access to the data partitioned organization unit of the agent can also raise an appeal. When a user raises an appeal from the View Evaluations screen, the status of the appeal appears as **New**. A notification is sent to users who are assigned the reviewer role in the appeals workflow once an appeal is raised. Users within the hierarchy of the employee who has handled the interaction for which appeal has been raised are also notified.

- The next step in the appeals process is to review the appeal. At least one of the employees defined as the reviewer role in the appeals workflow must review the appeal. Reviewers can view the list of all the appeals raised on the Appeals page. Reviewers can select options like Accept, Decline, Draw-score change, Draw-no score change. Post review, the status of the appeal changes to In Review state. The agents only view the appeal status on the Appeals page. Agents cannot view the reviewer name or the comments and actions that the reviewer has taken. A notification is sent to the evaluator who evaluated the interaction after reviewers provide their feedback. The verdict given by the reviewer is only a recommendation to the approver. The approver is not bound by the verdict of the reviewer.
- Once reviewed, the appeal needs to be approved. Users who belong to the approver role defined in the appeals workflow can approve or decline an appeal. The approver can select options like Accept, Decline, Draw-score change, Draw-no score change.
 - If the approver accepts all the criteria against which the appeal is raised, the status of the appeal changes to Approved.
 - If the approver declines all the criteria against which the appeal is raised, the status of the appeal changes to Declined.
 - Even if the approver accepts one criteria and marks the others as Decline, Draw - score change, Draw - no score change, the status of the appeal changes to Partially Approved.
 - Even if the approver selects one criteria as Draw - score change and marks the others as Decline or Draw - no score change, the status of the appeal changes to Partially Draw - score change.
 - Even if the approver selects one criteria as Draw - no score change and marks the others as Decline, the status of the appeal changes to Partially Draw - no score change.
- Post approval, the appeals process allows you to escalate the appeal. Only the roles above the employee, whose interaction was appealed, can escalate. The status of the appeal changes to Escalated. A notification is sent to users who are assigned the final approver role in the appeals workflow once an appeal is escalated.
- Post approval, decline, or escalation, the appeal moves to the final approve, final decline, or final draw state. Users who belong to the final approver role defined in the appeals workflow can change the state of the appeal to final approve, final decline, or final draw. The final approver can select options like Accept, Decline, Draw-score change, Draw-no score change.
 - If the final approver accepts all the criteria against which the appeal is raised, the status of the appeal changes to Final Approved.
 - If the final approver declines all the criteria against which the appeal is raised, the status of the appeal changes to Final Declined.
 - Even if the final approver accepts one criteria and marks the others as Decline, Draw - score change, Draw - no score change, the status of the appeal changes to Partially Final Approved.
 - Even if the final approver selects one criteria as Draw - score change and marks the others as Decline or Draw - no score change, the status of the appeal changes to Partial Final Draw - score change.

- Even if the final approver selects one criteria as Draw - no score change and marks the others as Decline, the status of the appeal changes to Partial Final Draw - no score change.
- Post approval or decline, a notification is sent to the agent who handled the interaction and the supervisor.

If the user who raised the appeal is not satisfied with the reevaluation scores and feedback by the evaluator, the user can reappeal against the evaluation.

Chapter 7: Managing coaching

Coach overview

The Coach module provides an automated framework for building personalized agent training programs using quality and performance data. Supervisors and managers can provide guidance and critical feedback to agents who require improvement in specific areas of performance. Support to define a list of performance attributes and create coaching plans for specific groups or employees is also available. The alerts and reports in Avaya Workforce Optimization Select ensure follow-up is done on time.

Using the Coach module, you can:

- Address coaching needs of an agent by identifying areas of focus and define parameters to specify skills and reasons for coaching.
- Build a coaching plan to define the number of coaching sessions agents need to complete within a specified period.
- Create task-oriented action plans in the form of coachings and assign them to agents to improve specific areas. Coachings are usually Instructor Led Training (ILT) sessions that are tracked in Avaya Workforce Optimization Select. Supervisors and managers can also link coachings to e-Learning courses and quizzes.

As a result, supervisors can generate relevant summary reports to view a snapshot of all the accepted and completed coaching assignments in the system.

- Define metrics that determine the criteria to measure performance. You can use a variety of sources to define a comprehensive metric library that align with your business processes and strategic organizational goals.
- Generate time-based scorecards to get a snap shot of the overall performance of employees, departments, roles, or sites.

Managing Measures

Measures overview

A measure is the raw transaction data associated with an employee. For example, the number of interactions handled, the total talk time, the number of evaluations completed, or the hold time of an interaction. You can view the measures in read-only mode. All measures are calculated and stored on a daily basis. You can use one or more measures to create custom metrics, which is further used in metric views and scorecards for analyzing the performance of an employee, a role, a department, and a site.

You can define an aggregation to specify whether you want the system to calculate the sum, average, minimum, or maximum range of the values that you enter. For example, you might want to create a custom metric where you manually enter values for the number of interactions or evaluations completed by all departments every quarter. In this case, you must use Data Entry as the metric source, define the time period as quarterly, and aggregation as Average.
- **External Import:** External data is imported in a specified template to create a custom metric. For example, if you are using an HR system to track the attendance of employees, you can use External Import as the metric source to import that data as a custom metric. Depending on the parameters that you define for the custom metric, the system provides a template, which you can download to enter values for the custom metric and import the same into the system.

 **Note:**

You cannot delete a custom metric if it is used in any metric view or is a part of a scorecard.

Managing Scorecards

Scorecards overview

Scorecards are statistical templates that are used for deriving performance data by using various metrics . Scorecards provide a systematic approach to measure, monitor, and act upon the different metrics in a contact center environment. These metrics are used by supervisors and managers to track and manage the performance of employees. You can build a scorecard at role, department, employee, or site level by adding metrics to analyze the performance during a specific period within your organization .

Depending on the kind of performance scorecard report you want to generate, you can build customized scorecards by using various filters. You can build time-based scorecards by associating one or more metrics, adding categories to group multiple metrics, and defining grades. The grades are defined at the metric level, category level, and at the scorecard level based on your specific requirements. The grading level in scorecards is used only for the purpose of grouping metrics.

Scorecards can be divided into two types depending on their views:

- Scorecard view: To generate reports for generic performance measurement based on employee, role, department, and site.

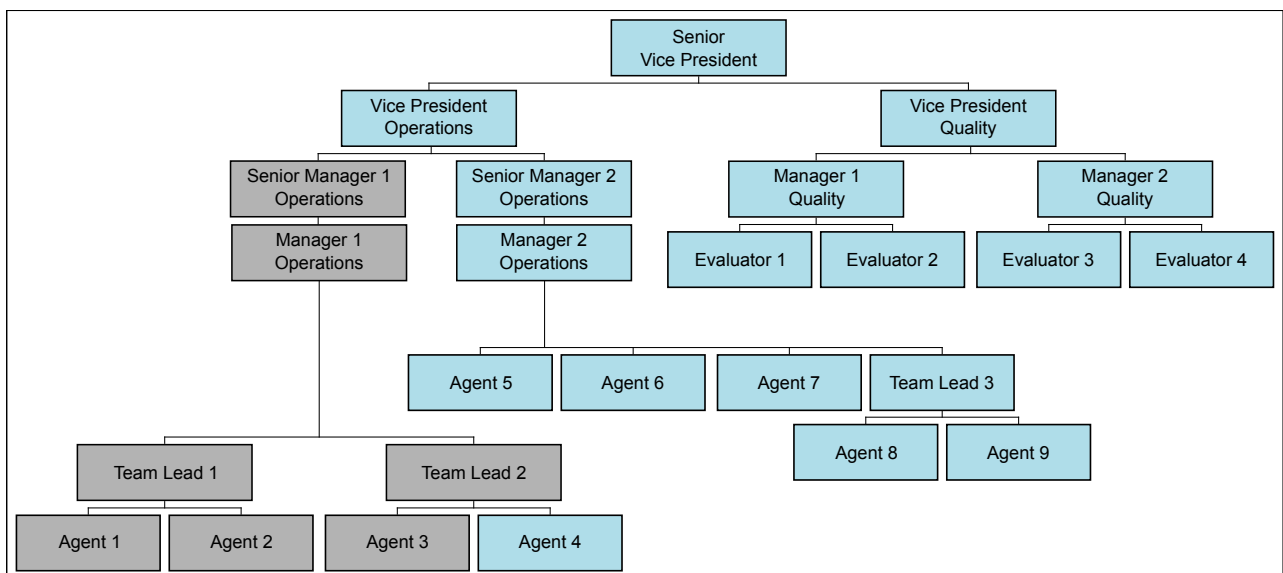

Each employee can view scorecard outputs of all the employees who are directly below that employee in the organizational hierarchy.

Refer to the following example to understand the drill-down options available for each employee in a scorecard output.

The following flowchart provides the access level for each designation. This is only a sample organizational hierarchy. In a real life scenario, the flowchart displays the names of the employees instead of the specific designations, and Site 1 and Site 2 is replaced by the names of the actual geographical locations.

- Site 1: Gray color
- Site 2: Blue color



The access level to the scorecard output for the designations are as follows:

Senior Vice President:

If you are the Senior Vice President, generating the scorecard output, with the **Group by** option as **Site**, you get a snap shot of both the sites, Site 1 and Site 2.

If you click on Site 1, you can view the details of the employees within the Senior Vice President hierarchy and the employees associated to that site as follows:

- Senior Manager 1, Operations: When you, as the Senior Vice President, click on the employee who is the Senior Manager 1, Operations, you can drill down until the last node in the hierarchy. The sample is as follows:
 - Manager 1, Operations
 - Team Lead 1
 - Agent 1
 - Agent 2
 - Team Lead 2
 - Agent 3
 - Agent 4 – The output does not display this employee, who is the Agent 4, because this employee belongs to a different geographical location, that is, Site 2 and not to Site 1.

Based on the hierarchy and the access privileges, all employees in the organization can perform the drill downs for the employees within the respective hierarchy.

Chapter 10: Analyze Speech

Speech overview

With the Speech module, you can perform precision search of recorded interactions. The third-party engine transforms audio recordings into actionable assets by producing search-optimized text output from single or multi-speaker audio file. You can search specific data from a large number of recorded interactions and provide valuable insights into the operations of the call center.

Using the Speech module you can take advantage of the following features:

- **Phrase Sets:** Create your library of words and phrases to track agent's performance as a supervisor.
- **Search:** Define your search criteria based on your business requirement.
- **Business Criteria:** Save the search as a business criteria to reuse or share the search criteria with one or more users..
- **Results:** View and manage speech results.

Avaya Workforce Optimization Select transcribes recorded interactions and identifies words and phrases defined as part of the search criteria, and highlights the words and phrases in the transcript.

 **Note:**

Supervisors and managers need statistics around individual or team performance. With this module in Avaya Workforce Optimization Select, you can generate different types of report views that are essential for the success of your business.

Using the Reports module, you can get:

- Predefined set of report templates for each module.
- Report output in various formats, such as PDF, Excel, HTML, and CSV.

Reports such as Evaluation Criteria Details, Evaluations Criteria Summary, Evaluations Overview, and Evaluations Section Summary do not support the PDF output.

- Reports scheduled to run automatically at the specified time.

 - b. Enter the time details, and select the time from when you want the schedule to begin and end.

Chapter 12: Managing notifications

Notifications overview

With the Notifications feature, you can receive real-time alerts and notices for predefined contact center conditions, both mission-critical and informational. Based on the Avaya Workforce Optimization Select modules purchased, you can subscribe to alerts to manage and control contact center activities. You can also specify whether you want these alerts and notices to appear in the notification inbox or sent to you through email. The notifications inform you about issues or situations that require immediate attention or notify you about general information on interactions.

The types of notifications are:

- Alerts: System-generated, real-time notifications that trigger when users cross the defined threshold value. For example, you can configure alerts that inform you about the exceeded number of holds, hold duration, and AHT by your team. The alerts that you can subscribe to depend on the threshold values set by the administrator.

 **Note:**

Avaya Workforce Optimization Select displays only the latest system-generated alert.

- Notifications: Custom messages that can be sent to users that you have access to. Notifications provide more information including general information and feedback.

Supervisors can use notifications to:

- Assess and measure employee performance to improve customer satisfaction.
- Send custom notices to employees that supervisors have access to, apart from system-generated alerts.
- Broadcast messages to users through email or have messages delivered to the notification inbox. Supervisors can broadcast messages as an alert or a notice and also send a custom message to members in the team.
- Send notifications during live monitoring of interactions to provide instant email feedback to the employee.







Viewing notifications

About this task

Use this procedure to view notifications that you receive as alerts or notices in your notifications inbox. When the user exceeds the threshold value of defined rule, the system triggers an alert

through email or directly to the notifications inbox. Users can also receive notices about general feedback or information during live interactions.

Chapter 14: Troubleshooting

Reports generation fails

Condition

When a user tries to generate a report, the system displays the following message: `Failed/Schedule is not working`. This message might get displayed frequently or when a particular criteria is selected.

Cause

Your browser might still be using earlier files which can cause display or access problems.

Solution

Clear the browser cache and log in into the application again.

Call or mail interaction details do not download

Condition

When a user tries to download an interaction mail or interaction details, the system displays an alert that prevents the action.

Cause

The interaction is tagged as Do not download or Do not email by another user.

Solution

1. Check to see if the interaction is tagged as do not download or do not email.
2. Send a request to the user who has tagged the interaction to remove the tag.

Records do not display in Interactions or View Evaluations

Condition

This issue occurs when a user who is logged in cannot view records in Interactions or View Evaluations.

Cause

The default view settings are not set properly.

Solution

1. Verify that the default view for Interactions displays `Today's Interactions`.
2. Verify that the default view for View Evaluations displays `Current Week Evaluations`.
3. Check the filters and values used within the view that is selected by the logged in user by creating a view with filters one by one and verify if the data imports correctly.

If the problem still persists, contact the system administrator.

Interaction playback fails

Condition

Interaction playback fails and the system displays the following error message: `You cannot play this interaction as the audio could not be loaded either because of unsupported file format or server/network failure.`

Cause

The browser does not support HTML5.

Solution

1. Install one of the following supported browser versions:
 - Internet Explorer 11 and later
 - Google Chrome 43.x and later
 - Mozilla Firefox 33.x and later
2. **(Optional)** If the problem persists, contact your system administrator.

Unable to evaluate imported WAV file interactions

Condition

When an evaluator tries to evaluate an interaction that is imported in WAV format on Internet Explorer (IE), the application displays the following message: `You cannot evaluate this interaction because the audio could not be loaded. It could either be because of unsupported file format or server/network failure.`

Cause

IE does not support WAV file format.

Solution

Use the following browsers to evaluate an interaction imported in WAV format:

- Google Chrome
- Mozilla Firefox
- Microsoft Edge

Permission denied to access training videos


Condition

When a user clicks the options to watch a training video in Avaya Workforce Optimization Select, the application displays the error message: `APIWrapper_scorm_12.js :: findAPI() :: ERROR HANDLED Permission denied to access property "API" on cross-origin object.`

Cause

Unknown issue from the host provider.

Solution

1. In the top-right corner of the **Home** page, click the  icon.
2. Click one of the following:
 - **Training Videos - Admin:** To watch the basics of administering Avaya Workforce Optimization Select. This training is intended for business partners and customers with an administrator role.
 - **Training Videos - Agent:** To watch the basics of using Avaya Workforce Optimization Select features with an agent role.
 - **Training Videos - Supervisor:** To watch the basics of using Avaya Workforce Optimization Select features with a supervisor role.

Avaya Workforce Optimization Select displays the following error message:
